WHEREAS, each year the San Diego Police Department sponsors the School Safety Patrol Summer Camp; and

WHEREAS, this camp is held at the Palomar County School Camp; and

WHEREAS, the School Safety Patrol Summer Camp affords fifth and sixth grade students an educational growth and recreational experience; and

WHEREAS, the San Diego Unified School District has agreed to provide transportation for students to and from the camp; and

WHEREAS, the transportation to be provided will consist of four (4) seventy (70) passenger buses to depart from San Diego Jack Murphy Stadium at 8:30 a.m. on June 24, July 1, July 8 and July 15, 1991; departing from Camp Palomar at 12:30 p.m. on June 27, July 4, July 11 and July 18, 1991, and;

WHEREAS, the agreement by the San Diego Unified School District to provide transportation is conditional on the specified terms, NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City of San Diego will assume total responsibility for the conduct of students while riding the bus, including but not limited to vandalism to school equipment; liability for damages resulting from objects thrown from the bus; and medical expenses for injury while entering, leaving or moving about the

bus;

BE IT FURTHER RESOLVED, that the City of San Diego will bear an equal share of the liability over and above insurance limitations if the school district meets the following performance standards: all drivers are licensed in accordance with the California Vehicle Code for transporting school students; all buses are Class "A" rated, meeting all safety regulations prescribed in the California Vehicle Code and the California Education Code; and that the school district's insurance policy remains in effect.

BE IT FURTHER RESOLVED, that the City Manager is authorized and empowered to enter into a letter of agreement with the San Diego Unified School District reflecting the terms of the resolution. This letter of agreement is on file in the Office of 278094 the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the expenditure of sixty-five thousand dollars (\$65,000.00) from Fund 10001, Department 901, Job Order No. 175702, and an amount not to exceed twenty-eight thousand dollars (\$28,000.00) from Fund 100, Department 110,

Organization 386, Object Account 4455 is hereby authorized solely and exclusively for the purpose of providing funds for the School Safety Patrol Camp.
