BE IT FURTHER RESOLVED that the City Auditor and Comptroller is hereby authorized to transfer the amount of \$44,796.30 from CIP 43-004.0, Annual Allocation for Freeway Relocation, to CIP 46-106.2, Annual Allocation for Sewer Pump Station Restoration.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$44,796.30 from CIP 46-106.2, is hereby authorized, solely and exclusively to fund this change order.

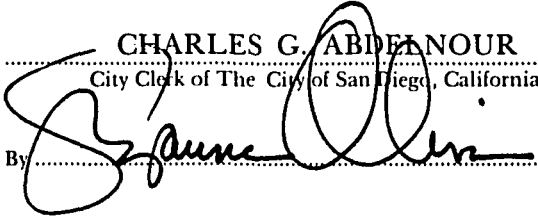
