BE IT FURTHER RESOLVED, that the City Council finds that project revisions now mitigate potentially significant effects on the environment previously identified in the Initial Study and that said Mitigated Negative Declaration is hereby approved.

## EXHIBIT A

## MITIGATION MONITORING AND REPORTING PROGRAM

Carmel Valley Neighborhood 1, Units 3 and 4 DEP No. 90-0471

This Mitigation Monitoring and Reporting Program is designed to ensure compliance with AB3180 (1988) during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. All mitigation measures contained in the Mitigated Negative Declaration (DEP No. 90-0471) shall be made conditions of Tentative Map No. 90-0471 and/or North City West Development Permit No. 90-0471 as present below.

## Paleontological Resources

- 1. A paleontologist shall be present at the pregrading meeting to discuss the mitigation procedures with the grading and excavation contractors, and the requirement for paleontological monitoring shall be noted on the grading plans.
- 2. A paleontological monitor shall be on-site at all times during the original cutting of undisturbed sedimentary rocks to monitor grading activities and collect any fossils which are unearthed. The paleontologist shall have the authority to temporarily stop or divert grading activities to allow recovery of fossil remains.
- 3. In the event that richly fossilferous shell or bone layers are encountered, a screen washing program shall be conducted. This will insure the recovery of important microfossil remains.
- 4. Following the salvage of macro- and microfossils from the project site, a limited preparation program shall be conducted to clean and repair fossil remains.
- 5. The prepared collection of salvaged fossils shall then be turned over to the San Diego Natural History Museum for permanent storage.

In addition to the map conditions outlined above, the following measure is a condition of North City West Development Permit No. 90-0471.

1. Prior to issuance of building permits, a report describing the results of the above monitoring program shall be reviewed and approved by the Principal Planner of the Environmental Analysis Section.
