

RESOLUTION NUMBER R-278111

ADOPTED ON JUNE 11, 1991

WHEREAS, the position of Planning Director was vacated on May 13, 1991; and

WHEREAS, the Mayor and Council, as appointing authority of the Planning Director, desire to form a screening committee for the purpose of selecting a new Planning Director; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that there be and is hereby established a Planning Director Selection Screening Committee for the purpose of reviewing and screening applications submitted by candidates for the position of Planning Director prior and preparatory to City Council interview of candidates.

BE IT FURTHER RESOLVED, that the Committee be and it is hereby directed to take all necessary actions to solicit applications for the position of Planning Director with consideration given to the following constraints on and phased guidelines for application solicitation:

A. Current City of San Diego Planning Department employees and County of San Diego residents [Phase I].

B. No limitation as to residency or employment [Phase II].

BE IT FURTHER RESOLVED, that Phase I solicitation and recruitment actions shall be constrained to a timeframe of six to eight weeks with the Personnel Director to determine and advise if a revised timeframe is workable.

BE IT FURTHER RESOLVED, that the Planning Department audit by the City Manager and Auditor and Comptroller shall be conducted simultaneously with Phase I.

BE IT FURTHER RESOLVED, that, if a candidate for Planning Director has not been selected at the completion of Phase I, then Phase II (a national search) shall be commenced and conducted.
