RESOLUTION NUMBER R- 278112

ADOPTED ON JUN 11 1991

WHEREAS, the Defense Base Closure Committee has retained both the Naval Training Center (NTC) and Marine Corps Recruit Depot (MCRD) as candidates for closure/realignment; and

WHEREAS, NTC is collocated with the fleet and, with its 142 training schools, is considered a complete training facility; and

WHEREAS, the Navy has stressed that it wants to have their training facilities close to the fleet; and

WHEREAS, MCRD is the finest training facility in the Marine Corps due in part to the extensive construction programs of the 1980s; and

WHEREAS, MCRD trains 55% of all new Marine Corps recruits each year; and

WHEREAS, closing MCRD and NTC will impact the current and future mission requirements of the Navy and Marine Corps; and

WHEREAS, closing MCRD and NTC will have extensive costs and manpower implications for the Marine Corps and Navy; and


WHEREAS, closing NTC and MCRD will have a \$302 million annual impact on the local economy; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby express its unequivocal support for the United States Naval Training Center and the United States Marine Corps Recruit Depot.

BE IT FURTHER RESOLVED, that this Council hereby requests that the Naval Training Center and Marine Corps Recruit Depot be deleted as possible candidates for closure/realignment.

BE IT FURTHER RESOLVED, that the Director of Legislative Services is directed to communicate with and provide a copy of this resolution to San Diego's congressional delegation and to the City's legislative representatives in Washington, D.C.


