WHEREAS, during the past year, Police Officer Michael Cash and Community Service Officers (CSOs) Lucia Church and Debbie Garrett of the Southeastern Area Storefront have increased the memberships of area Community Town Councils through their active involvement in informing neighborhood residents; and

WHEREAS, Officer Cash and CSOs Church and Garrett initiated the "Kids Week" program for school age children to increase positive communication as well as create trustful relationships between our youth and Police Department; and

WHEREAS, Officer Cash and CSOs Church and Garrett helped provide gifts and presents for over 800 economically disadvantaged children by organizing the Christmas program at Baker Elementary School; and

WHEREAS, Officer Cash and CSOs Church and Garrett initiated and sponsored the "Night at the Gulls" hockey game and "Day at Sea World" for over 300 disadvantaged children in the southeastern area; and

WHEREAS, the Southeastern Area Storefront, upon learning that a senior citizen's Social Security check was stolen, raised money to feed her; and

WHEREAS, the Southeastern Area Storefront directed donations and assisted a family with funeral arrangements for a 6-year old killed by a drunken driver the week before Christmas; and

WHEREAS, the Southeastern Area Storefront's Officer Michael Cash was named Law Enforcement Officer for 1991 by the South Bay Optimist Club; NOW, THEREFORE,
