BE IT RESOLVED, by the Council of The City of San Diego, that the low bids of 1. S.D. JANITORIAL SERVICES, and 2. EUGENE CARTER ENTERPRISES, INC. dba ENVIRONMENTAL MAINTENANCE SERVICE SPECIALIST are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of JANITORIAL MAINTENANCE AT CITY OPERATIONS STATIONS as may be required for a period of one (1) year beginning August 1, 1991 through July 31, 1992 as follows:

1. S. D. JANITORIAL SERVICES for Location I, Chollas Operations Station, for a total annual cost of \$21,613.34, terms 1% 21 days, with options to renew for four (4) additional one (1) year periods at a cost not to exceed 5% of prices in effect at the end of prior contract period.
2. EUGENE CARTER ENTERPRISES, INC. dba ENVIRONMENTAL MAINTENANCE SERVICE SPECIALIST for Location II - Control Operations Station and Location III - Rose Canyon Station for a total annual cost of \$24,828.84; terms 1% 20 days, with options to renew for four (4) additional one (1) year periods at a cost not to exceed 12% of prices in effect at end of prior contract period.

BE IT FURTHER RESOLVED, that in the event Contractor fails to perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and re-award to the next low responsible and responsive bidder or rebid that portion of the contract.
