WHEREAS, the City is prepared to apply for grant funding under said Act and can satisfy all requirements for making such application; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to apply for a grant in the amount of thirty-five thousand (\$35,000) dollars pursuant to the Library Services and Construction Act - Foreign Language Materials Acquisition, for the purpose of augmenting the collection of Spanish Language Materials in the City Library.
