BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, agreements with City Heights Community Development Corporation (operating budget) and City Heights Community Development Corporation to carry out the State Route 15 - 40th Street Visions Project implementation program and other specified economic development activities, under the terms and conditions set forth in the Agreements on file in the office of the City Clerk as Document No.

RR- 278483 -1 and RR- 278483 -2, together with reasonably necessary modifications or amendments thereto which do not increase projects scope or cost and which the City Manager shall deem necessary from time to time to carry out the purposes and intent of the projects and agreements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed two hundred seventy-six thousand (\$276,000) dollars consisting of two hundred thousand (\$200,000) dollars for City Heights Community Development Corporation (operating budget) from Fund 18527, Department 4016, Organization 1601; and, seventy six thousand (\$76,000) dollars for City Heights Community Development

Corporation (for State Route 15 Visions Project) from Fund 18527,  
Department 4016, Organization 1605, is hereby authorized solely  
and exclusively for the purpose of providing funds for the above  
projects.




