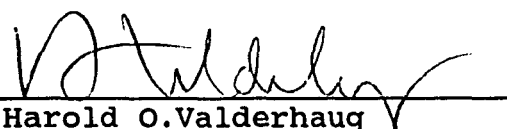
RESOLUTION NUMBER R- 278484

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, agreements with GOLDEN HILL COMMUNITY DEVELOPMENT CORPORATION and LINDA VISTA COMMUNITY DEVELOPMENT CORPORATION, for specified economic development activities, under the terms and conditions set forth in the agreements on file in the office of the City Clerk as Document Nos. RR- 278484-1 and RR- 278484-2, together with reasonably necessary modifications or amendments thereto which do not increase projects scope or cost and which the City Manager shall deem necessary from time to time to carry out the purposes and intent of the projects and agreements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$176,000, consisting of \$90,000 for Golden Hill Community Development Corporation from Fund 18527, Department 4016, Organization 1602, and \$86,000 for Linda Vista Community Development Corporation from Fund 18527, Department 4016, Organization 1603, is hereby authorized, solely and exclusively for the purpose of providing funds for the above projects.
