RESOLUTION NUMBER R- 278498

ADOPTED ON AUG 05 1991

WHEREAS, the Council of The City of San Diego adopted Resolution Number R-275487 on April 16, 1991, approving a fee schedule for cost recovery of City vehicle impound services and authorizing the City Manager to review and adjust such fees annually or as costs of services increase; and

WHEREAS, the City Manager desires authority to expand the Vehicle Impound Cost Recovery Program to include any and all vehicles impounded under authority of the California Vehicle Code or the San Diego Municipal Code, with the exception of stolen vehicles; and

WHEREAS, expansion of the vehicle impound cost recovery program would add to the current fee schedule maintained in the Office of the City Clerk, as Document Number RR-275487, vehicles impounded for the following actions:

- Illegally parked vehicle blocking a legally parked vehicle;
- Unattended vehicle with a ringing alarm;
- Vehicle illegally parked in handicap parking space;
- Blocking fire hydrant access;
- Unattended or unattached trailers;
- Illegal parking in City parking lots/facilities; and

WHEREAS, the City Manager has included in the proposed Fiscal Year 1992 budget an additional position in the Treasurer's Office; and

WHEREAS, the City Manager will discuss during the budget

hearing process an additional 0.6 position in the Treasurer's Office to expedite the processing of vehicle impound releases, NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized to expand the Vehicle Impound Cost Recovery Program to include any and all vehicles impounded under authority of the California Vehicle Code or the San Diego Municipal Code, with the exception of stolen vehicles.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby, authorized to add or delete from the authorized impound services listed on the fee schedule and to review and adjust the fee schedule annually or as costs of services increase or decrease.
