

RESOLUTION NUMBER R- 278501

ADOPTED ON AUG 05 1991

WHEREAS, on August 17, 1991, at the San Diego Sports Arena, Terry Norris, the World Boxing Council (WBC) Super Welterweight Champion, will highlight the return of championship boxing to America's Finest City when he defends his WBC title against "Irish" Brett Lally in a 12-round bout; and

WHEREAS, Mr. Norris' worthy opponent, Brett Lally, is the NABF Super Welterweight Champion and rated No. 3 by the WBC; and

WHEREAS, Mr. Norris will defend, for the fourth time, the WBC Super Welterweight Championship he first won on March 31, 1990 with a first round knockout of John "The Beast" Mugabi; and

WHEREAS, on February 9, 1991, Mr. Norris placed himself squarely on the boxing map with a 12-round unanimous decision over Sugar Ray Leonard, during which match Mr. Norris recorded two knockouts in the second and seventh rounds, respectively; and

WHEREAS, a product of Joe Sayatovich's First Fighter Squadron in Campo, California, and trained by Abel Sanchez, Mr. Norris has been boxing professionally since 1986 and defended his belt on July 13, 1990 with a 12-round decision over former champion Rene Jacquot and scored an 8-round knockout of Donald Curry on June 1, 1991; and

WHEREAS, originally from Lubbock, Texas, and the younger brother of former NABF Heavyweight Champion Orlin Norris, Terry has demonstrated superior boxing skills which are reflected in


