WHEREAS, the Council of The City of San Diego directed the City Manager to analyze, review and report on the various options available to the City regarding office space for City employees in the Centre City area; and

WHEREAS, the City Manager has analyzed and reviewed the options available and recommends that the City pursue a two-pronged strategy in which long-term leases be negotiated and executed for a period of up to ten (10) years to take care of short-term office needs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manger be and he is hereby authorized and empowered to negotiate long-term leases in the Centre City area (up to ten (10) years), on behalf of City in order to insure adequate office space for City employees at reasonable lease rates with the leases to be returned to the City Council for its consideration prior to execution.
