
ADOPTED ON AUG 05 1991

WHEREAS, Ordinance No. O-17172 requires that owners of high-rise buildings or structures that contain significant quantities of asbestos equip the entire gross square footage of the building or structure with an automatic fire sprinkler system by January 1, 1996; and

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney be directed to prepare an ordinance which amends Ordinance No. O-17172 and extends the deadline for compliance with the requirement that any high-rise building or structure that contains significant quantities of asbestos be equipped with an approved automatic fire sprinkler system from January 1, 1996 to January 1, 1999.
