WHEREAS, the permit was set for a public hearing to be conducted by the Council of The City of San Diego; and


WHEREAS, the issue was heard by the Council on AUG 06 1991; and

BE IT FURTHER RESOLVED, that the Council finds, based upon the Initial Study and any comments received, that there is no substantial evidence that the project will have a significant effect on the environment and therefore said Negative Declaration is hereby approved.
