RESOLUTION NUMBER R-278531

ADOPTED ON AUGUST 6, 1991

WHEREAS, on August 6, 1991, the Council for The City of San Diego, considered the appeal of Mr. Fred Oliver, by Patricia Kent of Worley, Schwartz, Garfield and Rice, from the decision of the Historical Site Board in designating 2260 Columbia Street (Foster-Kleiser Building) as a historic site and listed as Site No. 255 in the Register of Historic Landmarks; and

WHEREAS, in reaching their decision, the City Council considered the decision of the Historical Site Board, the recommendation of the City Architect, the written materials presented prior to and at the public hearing and heard public testimony; and


WHEREAS, the City Council found that the Foster-Kleiser Building did not have sufficient historic or architectural merit to warrant designation as a historic site; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of Mr. Fred Oliver, by Patricia Kent of Worley, Schwartz, Garfield and Rice, is granted and the decision of the Historical Site Board in designating 2260 Columbia Street

(Foster-Kleiser Building) as a historic site and listed as Site No. 255 in the Register of Historic Landmarks is hereby overturned.
