RESOLUTION NUMBER R-278532

ADOPTED ON AUGUST 6, 1991

WHEREAS, on August 6, 1991, the Council for The City of San Diego, considered the appeal of Mr. Fred Leonard, by Patricia Kent of Worley, Schwartz, Garfield and Rice, from the decision of the Historical Site Board in designating 602 West Fir Street (Captain Amos Pettengill House/Piriano House) as a historic site and listed as Site No. 272 in the Register of Historic Landmarks; and

WHEREAS, in arriving at their decision the City Council considered the decision of the Historical Site Board, the recommendation of the City Architect, the materials presented prior to and at the public hearing and heard public testimony at the hearing; and

WHEREAS, the City Council found that the Captain Amos Pettengill House/Piriano House did not have sufficient historic or architectural merit to warrant designation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of Mr. Fred Leonard, by Patricia Kent of Worley, Schwartz, Garfield and Rice, is granted and the decision of the Historical Site Board in designating 602 West Fir Street (Captain Amos Pettengill House/Piriano House) as a historic site and

listed as Site No. 272 in the Register of Historic Places is
hereby overturned.
