BE IT RESOLVED, by the Council of The City of San Diego, that the low bids of 1. GEO. F. KENNEDY INC., 2. TALIN TIRES INC., and 3. MACHO TIRE CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of TIRES AND TUBES as may be required for a period of one (1) year beginning September 1, 1991 through August 31, 1992, per prices on file in the Purchasing Department as follows:

1. GEO. F. KENNEDY INC. for Group I - Radial/Tubeless, Passenger Car/Compact Truck; and Group IV - Radial/Bias Tube and Tubeless, Medium/Heavy-Duty Truck, for a total estimated cost of \$325,541.01; terms net 30 days, plus sales tax.

2. TALIN TIRES INC. for Group II - Radial Police High Speed; Group III - Radial/Bias Tube and Tubeless, Light Trucks; Group V - Bias/Tube, Off-Road Tires; and Group VI - Miscellaneous Fire Department Truck Tires, for a total estimated cost of \$209,216.81; terms 2% 20 days, plus sales tax.

3. MACHO TIRE CO. for Group VII - Inner Tubes, for a total estimated cost of \$7,726.02; terms net 30 days, plus sales tax.
