
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the low bid of I TRE CORP. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing HAULING SERVICE FOR REMOVING AND DISPOSING OF WET SCUM as may be required for a period of one (1) year beginning September 1, 1991 through August 31, 1992, at a cost of \$0.35 per gallon, for a total estimated annual cost of \$91,000.00; terms net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 8.5%.

2. That in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder or to obtain this service on the open market until the requirement can be rebid.
