BE IT FURTHER RESOLVED, that the expenditure, of \$77,850.00 from CIP No. 62-292.0 DIF Funded, Fund No. 79512, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and

Comptroller upon advice from the administering department, to
retain excess monies, if any, in Fund 79512.
