BE IT FURTHER RESOLVED, that the expenditure of \$80,000.00 from CIP No. 29-452.0, SANTA CLARA POINT RECREATION CENTER - REQUIREMENTS, Mission Beach - Urban Community Fund No. 79522, is hereby authorized solely and exclusively for providing funds for

said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserve.
