
RESOLUTION NUMBER R- 278562

GREENE & TERRI GREENE, executed in favor of The City of San Diego, bearing dates of December 31, 1990, and January 5, 1991, a copy of which deed is on file in the office of the City Clerk as Document No. RR-278562, granting to said City an easement for public street purposes in Lot 64 of Del Sur Unit No. 1, Map No. 1259, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 65TH STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.

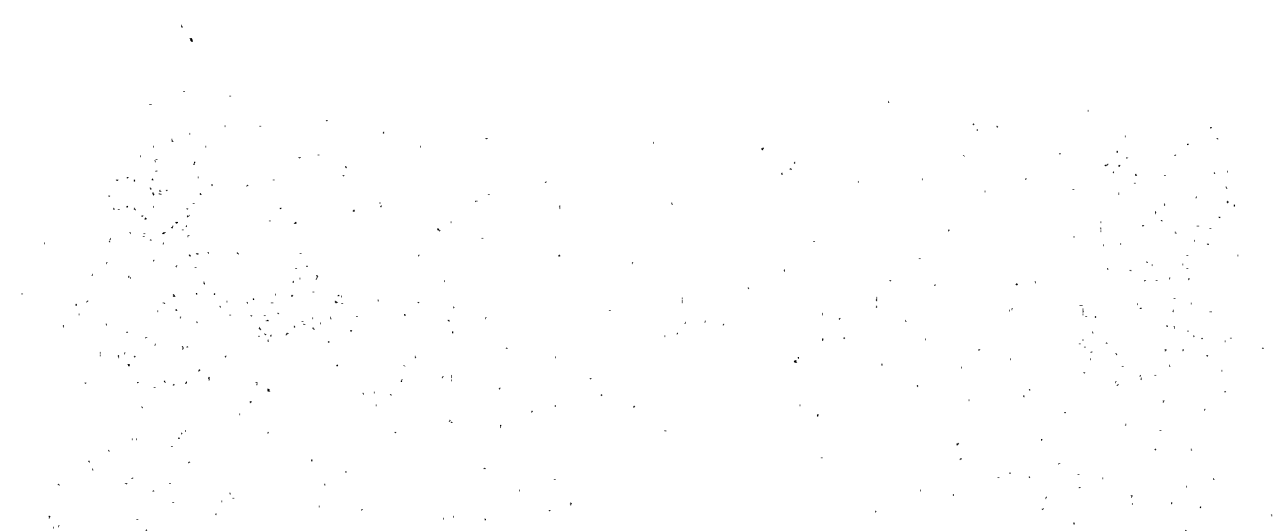
