WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,



SUGGESTION: Mr. Ketchem was a fire engineer at the time of submittal. He suggested that air aspirated nozzles be constructed of PVC pipe. This is considered to be a significant operational improvement.

NAME(S): David L. Gerber
DEPARTMENT: General Services/Buildings
AMOUNT: \$197.03
SUGGESTION: Mr. Gerber was a Refrigeration Mechanic at the time of this suggestion. He suggested installing demand limiting on the Centravac water chiller at the Library. This is the remainder of his award based on actual savings of \$1,290.10.
