RESOLUTION NUMBER R- 278587

ADOPTED ON SEP 09 1991

WHEREAS, since June 1989, Aetna Casualty and Life has donated more than eight hundred fifty (850) video cameras to over eighty-three (83) law enforcement agencies under its "Eye on DUI" program; and

WHEREAS, video cameras provide an effective tool in the fight against driving under the influence of alcohol or drugs; and

WHEREAS, Aetna Casualty and Life is willing to donate under its "Eye on DUI" program, and the San Diego Police Department desires to accept, twenty (20) video cameras for installation in police vehicles assigned to the traffic division; and

WHEREAS, the San Diego Police Department, in return for the donation of twenty (20) video cameras will agree to provide Aetna Casualty and Life with statistics of videotaped and non-videotaped driving under the influence arrests including the judicial disposition of those cases for a twelve-month period; and

WHEREAS, the donation is valued at twenty-five thousand, seven hundred dollars (\$25,700.00) and the annual costs for supplies and camera upkeep is estimated at approximately four thousand dollars (\$4,000.00) offset by reduced court overtime costs; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to accept a

donation of twenty (20) video cameras valued at twenty-five thousand, seven hundred dollars (\$25,700.00) from Aetna Casualty and Life for installation in police vehicles assigned to the San Diego Police Department's Traffic Division.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Council, for and on behalf of the City, publicly expresses the gratitude of the citizens of San Diego for this act of civic generosity.
