WHEREAS, retirees have several options available to them in regard to providers of health coverage; and

WHEREAS, it was determined that an additional health coverage provider would be beneficial to the retiree who is medicare eligible; and

WHEREAS, the Retirement Administrator has recommended and the Retirement Board has selected Secure Horizons/Pacific Care to provide those services to eligible retirees; and

WHEREAS, this health insurance contract is somewhat unique in that it will be administered by the Retirement System and not the Risk Management Department; and

WHEREAS, the Retirement Board of Administration approved Secure Horizons/Pacific Care coverage at the regular Board meeting of October 19, 1990; and

WHEREAS, it is now necessary and appropriate to authorize the execution of an agreement for health insurance coverage pursuant to the proposal submitted and approved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the President of the Board of Administration for the City Employees Retirement System be, and he is hereby authorized and empowered to execute an agreement with SECURE HORIZONS, PACIFIC

CARE OF CALIFORNIA, a federally qualified Health Maintenance Organization, to provide health care for eligible retirees pursuant to the terms and conditions of the Medical and Hospital Group Subscriber Agreement, a copy of which is on file in the office of the City Clerk as Document No. RR- 278600together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Retirement Administrator shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.
