

RESOLUTION NUMBER R-278613

ADOPTED ON SEPTEMBER 9, 1991

WHEREAS, on August 5, 1991, the City Council received an informational report regarding the Committee system and the costs involved therein; and

WHEREAS, the Council determined that a further study of the matter was necessary in order to examine all of the ramifications, pro and con, of the system; and

WHEREAS, it was decided to appoint an ad hoc subcommittee of the Council to accomplish this study and develop recommendations for the Council to consider; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that an ad hoc committee of the Council, consisting of Councilmembers Tom Behr (as Chair), Abbe Wolfsheimer, Judy McCarty and Mayor Maureen O'Connor, be and it is hereby appointed for the purpose of examining the Council Committee system and making appropriate recommendations thereon.

BE IT FURTHER RESOLVED, that the ad hoc committee shall, as a result of the examination of the Committee system,

1. Develop recommendations for a new committee system to reflect the current governmental structure and the issues which face the City;
2. Develop alternatives to the Committee system;
3. Analyze staffing efficiencies with the direction that no additional staff will be hired should the Committee system or any



4. Consider and make recommendations on the option of eliminating the Committee system altogether.

BE IT FURTHER RESOLVED, that the ad hoc committee shall present recommendations to the City Council by October 1, 1991 for Council action, as deemed most appropriate, no later than the end of November 1991.
