RESOLUTION NUMBER R-278614

ADOPTED ON SEPTEMBER 9, 1991

WHEREAS, the City Council discussed as an "off-docket" item on September 9, 1991, the very serious problem of waste disposal; and

WHEREAS, the discussion centered around the issue of garbage generated in the North County being sent by the County south to City of San Diego landfills, particularly Miramar; and

WHEREAS, the garbage disposal situation is of emergency proportions, not only in North County but in the county-wide area, impacting all landfills and especially Miramar which is the closest available facility; and

WHEREAS, it is deemed absolutely necessary by this Council that the County Board of Supervisors immediately make necessary and appropriate provision for a new North County landfill; and

WHEREAS, it is also deemed imperative by this Council that under no circumstances should garbage and trash generated outside of the City of San Diego be taken to the Miramar landfill; and

WHEREAS, it is necessary that the County of San Diego resolve and indicate publicly the resolution of the waste disposal problem in and from the North County area, particularly that emanating from lessened use of the San Marcos landfill; and

WHEREAS, the County Board of Supervisors will be meeting on September 10, 1991 to discuss this matter, with recommendations from their staff to send that garbage and trash south to Miramar; and

WHEREAS, it is not only appropriate but absolutely necessary, that the City Council attend that meeting to register and make known to the Board of Supervisors the stance of the City of San Diego in this matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Public Services and Safety Committee immediately begin hearings on this situation and all the resultant ramifications.
2. That in light of the fact that the County has been found by the State to be in violation of exceeding trash and garbage dumping limitations into Otay and Sycamore landfills, the City Manager investigate and report to Council, as soon as possible, if, how, and why the expansion of Sycamore and associated environmental reports were approved without securing Council approval.
3. That this Council, at the appropriate time on Tuesday, September 10, 1991, recess to allow members to testify before the San Diego County Board of Supervisors to make known, in a clear and unambiguous manner, its intention to protect the health and welfare interests of the citizens of San Diego.
