BE IT RESOLVED, by the Council of The City of San Diego, that the low and low acceptable bids of 1. QUINTEX MOBILE COMMUNICATIONS, 2. PAC TEL CELLULAR, and 3. U.S. WEST CELLULAR are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of CELLULAR RADIO TELEPHONE EQUIPMENT AND SERVICE as may be required for a period of one (1) year beginning September 1, 1991 through August 31, 1992, per prices on file in the Purchasing Department as follows:

1. QUINTEX MOBILE COMMUNICATIONS, low bid for Section I, Item 1 - Portable Hand Held Unit, Audiovox Model PT-90; terms net 30 days, plus sales tax.
2. PAC TEL CELLULAR, low acceptable bid for Section I, Item 2 - Deluxe Portable Hand Held Unit, OKI-900; and for Items 3 and 3A, Packset Unit and Adapters, Motorola TX-200; and low bid for Item 4, Vehicular Mount Full Feature Unit, Audiovox PTC-10; terms net 30 days plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with no price escalations.
3. U.S. WEST CELLULAR, low bid for Section II - Service and Air Time; terms net 60 days, with options to renew the contract for four (4) additional one (1) year periods, with no price escalations.
