ADOPTED ON SEPTEMBER 10, 1991

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO LEVYING AN ANNUAL ASSESSMENT WITHIN THE PREVIOUSLY ESTABLISHED LA JOLLA BUSINESS IMPROVEMENT DISTRICT FOR JULY 1, 1991 THROUGH JUNE 30, 1992.

WHEREAS, the Council of The City of San Diego ("Council"), in accordance with the Parking and Business Improvement Association Law of 1989 (Streets and Highways Code section 36500 et seq.) wishes to continue the promotional activities within the existing La Jolla Business Improvement District (the "District"); and

WHEREAS, the Council, by Resolution No. R-278073 on June 10, 1991 set the date of June 24, 1991 at the hour of 2:00 p.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, as the time and place when and where any and all interested persons having a desire to be heard may appear and state their views for or against the continuance of the District or the furnishing of specific types of improvements or activities within the District; and

WHEREAS, the Council, by Resolution No. R-278072 on June 10, 1991, accepted the budget report for the La Jolla Business Improvement District within the City of San Diego; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby confirms the budget report for the
