WHEREAS, it is now necessary to make full and final payment to the Arent, Fox firm for services rendered up to the successful conclusion of the hearing process; NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby fully authorized to pay the sum of \$122,793.03 to the firm of Arent, Fox, Kintner, Plotkin & Kahn as payment in full for expert outside counsel services in the San Diego Gas & Electric/Southern California Edison proposed merger case.
