
BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. MULTIPLIER INDUSTRIES CORP., 2. ALEXANDER BATTERY CO. WEST, 3. HOUSE OF BATTERIES, and 4. PERIPHEX are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of RADIO, PAGER AND CELLULAR TELEPHONIC BATTERIES as may be required for a period of one (1) year beginning September 1, 1991 through August 31, 1992 per prices on file in the Purchasing Department, as follows:

1. MULTIPLIER INDUSTRIES CORP., low bid for Items 1, 6, 7, 9, 10, 16, 17, 18, 19, 21, 22, 27, 28 and 29, for a total estimated cost of \$23,270.00; terms net 30 days, plus sales tax; with options to renew the contract for two (2) additional one (1) year periods with no price increase.
2. ALEXANDER BATTERY CO. WEST, low acceptable bid for Item 2, low bid for Items 3, 4, 5, 8, 12, 14, 15, 20, 23, 26, 30 and 31, for a total estimated cost of \$19,780.00; terms net 30 days, plus sales tax; with options to renew the contract for two (2) additional one (1) year periods, with price escalations not to exceed 10% of prices in effect at the end of each prior year.

3. HOUSE OF BATTERIES, low bid for Items 11, 13, and 25, for a total estimated cost of \$1,770.00; terms net 30 days, plus sales tax; with no options to renew.
4. PERIPHEX, low bid for Item 24, for a total estimated cost of \$1,325.00; terms net 30 days, plus sales tax; with options to renew the contract for two (2) additional one (1) year periods, with price escalations not to exceed 50% of prices in effect at the end of each prior year.
