BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF CROWN POINT TRUNK SEWER.

BE IT FURTHER RESOLVED, that the expenditure of \$598,657.00 from Sewer Revenue Fund 41506, CIP 44-001.0, and \$18,477.00 from CIP 22-079.0, Northern Wildlife Reserve-Requirements, Fund No. 10507, Fiesta Island Sludge Mitigation, is hereby authorized solely and exclusively for providing funds for said project and related costs.
