
RESOLUTION NUMBER R- 278728

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of deeds of SUNBURST HOMES CORPORATION, a California corporation, bearing date of May 6, 1991; RAYMOND HAMPE, FREDERICK W. HAMPE, EANNE B. HAMPE and RICHARD B. WILLIAMS, dated March 15 and 16, 1991, and POWAY UNIFIED SCHOOL DISTRICT, dated April 1, 1991, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 278728 - 1, RR- 278728 - 2 and RR- 278728 - 3, granting to said City a portion of the Southwest Quarter of the Northeast Quarter of Section 12, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named ADOBE BLUFFS DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
