WHEREAS, the Drug Abuse Resistance Education (DARE) Program is designed to place police officers in direct contact with the City's youth through the elementary schools to provide the City's youth with information and education on the resistance of drug abuse; and

WHEREAS, the Weingart Foundation's grant will enable DARE to initiate a pilot program at the junior high school by this funding of one officer and supporting equipment; and

WHEREAS, the San Diego Police Department will submit progress reports to the Weingart Foundation at six (6) month intervals and a final report when funds have been completely expended, NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized to accept a grant of seventy-eight thousand, four hundred sixteen dollars (\$78,416.00) from the Weingart Foundation for a pilot of the Drug Abuse Resistance (DARE) Program at the junior high school level; and

Diego, that the Council, for and on behalf of the City, publicly expresses the gratitude of the citizens of San Diego for this act of civic generosity.

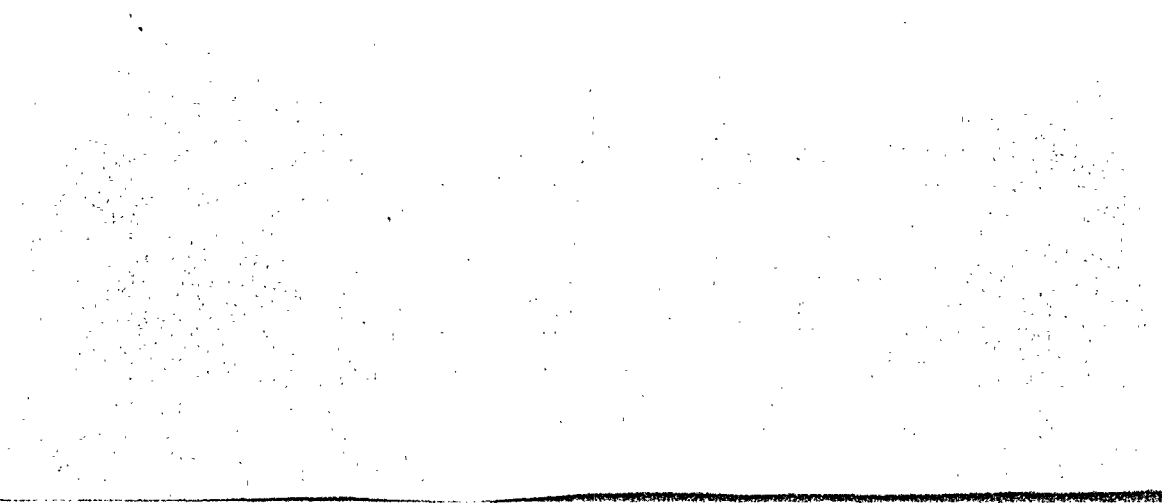
