RESOLUTION NUMBER R- 278738

ADOPTED ON OCT 07 1991

WHEREAS, in February 1990, the City Council approved the design for the City Gates public art projects at North Gate ("Gate of Light" by Ellen Phillips) and South Gate ("Los Portales de Chicano Park" by Robin Brailsford, Ysela Chacon, and Roberto Salas); and

WHEREAS, the cost for each project was originally established at one hundred fifty thousand (\$150,000), or three hundred thousand (\$300,000) dollars total; and

WHEREAS, the Commission for Arts and Culture identified South Gate as a funding priority because the murals in Chicano Park are being renovated; and

WHEREAS, an application was submitted to the National Endowment for the Arts/Visual Arts Program for funding in support of the South Gate proposal; and

WHEREAS, the National Endowment for the Arts ("NEA") grant request was awarded at twenty thousand (\$20,000) dollars on condition that the City provide matching funds and on other general conditions applicable to the NEA grant; and

WHEREAS, at the May 17, 1991, Commission for Arts and Culture meeting, the Commission unanimously recommended acceptance of the NEA grant to be matched by twenty thousand (\$20,000) dollars from the Public Art Fund; and

WHEREAS, the City Manager in his report No. 91-414, dated Oct. 2, 1991, concurs with the Commission's recommendation, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City accept the twenty thousand (\$20,000) dollar grant from the NEA in support of the planning and fabrication of "Los Portales de Chicano Park" (South Gate) on the terms and conditions specified by the NEA.

BE IT FURTHER RESOLVED, that the City Council appropriates twenty thousand (\$20,000) dollars from the Fund for Public Art to match the NEA grant.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend these funds to match the NEA grant for the planning and fabrication of "Los Portales de Chicano Park" (South Gate).
