BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-274888 dated December 12, 1989, be amended by amending section 4 thereof to appoint Councilmember Tom Behr to replace Councilmember Ron Roberts as the City's primary representative to the Governance Advisory Group.
