WHEREAS, said notice of intention has been given by posting in the office of the City Clerk; and

WHEREAS, it is desirable that the variable rate sewer service charge presently applicable to the single-family domestic customer class pursuant to Section 3 of Resolution No. R-275941 adopted on June 19, 1990, be replaced with a flat rate for the purpose of enhancement of equity; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Section 3 of Resolution No. R-275941 shall be rescinded.
- 2. That the domestic sewer service charge for each single family dwelling serviced by a separate water meter shall be the amount of nineteen dollars and twenty-four cents (\$19.24) per month.
- 3. That the remaining provisions of Resolution No. R-275941 shall remain in full force and effect until further action of this Council.
