RESOLUTION NUMBER R-278779

ADOPTED ON OCTOBER 8, 1991

WHEREAS, there is an increase of crime, graffiti, and related activities on the vehicles of many public transit systems; and

WHEREAS, the cost for law enforcement required to be present at all times upon the vehicles of public transit is prohibitively high; and

WHEREAS, off duty police officers, sheriffs, undersheriffs, and deputy sheriffs may ride the public transit lines at a minimal cost to the public; and

WHEREAS, the Assembly of the State of California in-House Resolution No. 19 requests that the operator of any public transportation system which receives funds pursuant to the Mills-Alquist-Deddeh Act allow off-duty police officers, sheriffs, undersheriffs, and deputy sheriffs of a county in which the public transportation systems operates to use the public transportation system without charge; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby encourage the Metropolitan Transit Development Board to implement the recommendation outlined in Assembly Resolution No. 19 to allow off duty police officers, sheriffs, undersheriffs, and deputy sheriffs of a county in which

the public transportation systems operates to use the public transportation system without charge.

BE IT FURTHER RESOLVED, that the free use of public transportation systems by off-duty police officers is encouraged and approved for the San Diego Police Department and that any policies and regulations relating thereto be amended as deemed necessary by the City Manager and Police Chief.
