A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE REVOLVING LOAN FUND PROGRAM FOR THE SOUTHEAST ECONOMIC DEVELOPMENT CORPORATION.

WHEREAS, The City of San Diego through the Southeast

Economic Development Corporation ("SEDC") is engaged in

activities necessary to carry out and implement business

development for the Southeast San Diego area; NOW, THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That SEDC's Revolving Loan Fund program, as set out in the Memorandum to the Honorable Mayor and Members of the City Council on the same subject, on file in the office of the City Clerk as Document No. RR- $\frac{278625}{}$ , is hereby approved.
- 2. That the City Council hereby approves an amendment to the 1990 Community Development Block Grant ("CDBG") Program Fund 18524 Budget to transfer one hundred thousand dollars (\$100,000) from the Incubator Project to the SEDC--Revolving Loan Fund Project.
- 3. That the City Council hereby approves an amendment to the 1989 CDBG Program Fund 18525 by transferring fifty-nine thousand dollars (\$59,000) from SEDC--Community Business Development Project to the SEDC--Revolving Loan Fund Project.
- 4. That the City Manager or his designee, be and he is hereby authorized and empowered to execute loan agreements not to

exceed twenty-five thousand dollars (\$25,000) per individual loan, pursuant to the terms and provisions of the Revolving Loan Fund Program.

5. That the expenditure of three hundred twenty thousand dollars (\$320,000) from CDBG Fund 18525 and two hundred sixtyone thousand dollars (\$261,000) from CDBG Fund 18526, is hereby authorized, solely and exclusively for the purpose of providing funds for the individual loans not to exceed twenty-five thousand dollars (\$25,000) each.
