BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$189,900.00 from the Annual Allocation Various Lakes (CIP No. 73-230) to Water Revenue Fund 41502 (CIP No. 74-910), and authorizing the expenditure, not

to exceed \$839,900.00 from Water Revenue Fund 41502 (CIP No. 74-910), for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to CIP No. 73-230.0.
