WHEREAS, The City of San Diego is the owner of a portion of the Southwest Quarter of Section 31, Township 12 South, Range 1 East, San Bernardino Base and Meridian; and

WHEREAS, the City desires to negotiate the sale of said land to the STATE OF CALIFORNIA, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

- That the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a Right of Way Contract with the STATE OF CALIFORNIA, a copy of which is on file in the office of the City Clerk as Document No. RR- 278850connection with the above property.
- That the City Clerk is hereby authorized and directed to deliver the deeds and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
