BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and directed to submit, for and on behalf of said City, an application to the State of California for twenty-five thousand (\$25,000) dollars in grants pursuant to the Library Services and Construction Act for the purpose of establishing and developing five (5) pilot Grandparents and Books Programmes. The pilot programs will be established at the Central Library and the four (4) following library branches: Beckwourth, East San Diego, Otay Mesa, and San Ysidro.

BE IT FURTHER RESOLVED, that the City Manager or his representative is authorized to perform all acts necessary to secure and expend the funds.

BE IT FURTHER RESOLVED, that the information to be supplied on said application has been considered and that all requirements for making application pursuant to said Act have been fulfilled.
