RESOLUTION NUMBER R- 278861

ADOPTED ON OCT 21 1991

WHEREAS, the City of San Diego is required by State Law (AB 939, the Integrated Waste Management Act) to prepare two comprehensive Waste Management documents: (1) a Source Reduction and Recycling Element, and (2) a Household Hazardous Waste Element; and

WHEREAS, Resolution No. R-277691, adopted on April 15, 1991 authorized the City Manager to accept \$20,000 grant money from the County for the preparation of the two elements; and

WHEREAS, the County of San Diego has authorized the expenditure of an additional \$20,000 in grant money to The City of San Diego to be used for the preparation of the two elements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to accept from the County of San Diego, \$20,000 of additional grant money to be used for the preparation of two comprehensive Waste Management documents: (1) a Source Reduction and Recycling Element, and (2) a Household Hazardous Waste Element, as required by State of California law - AB 939, the Integrated Waste Management Act.

BE IT FURTHER RESOLVED, that the authorized expenditure of \$70,000 for consulting services related to the preparation of the

two comprehensive Waste Management documents be increased to \$90,000.00.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to accept any additional grant money that may be available for preparation of the two comprehensive Waste Management documents, and to amend the agreement with the County without Council action.
