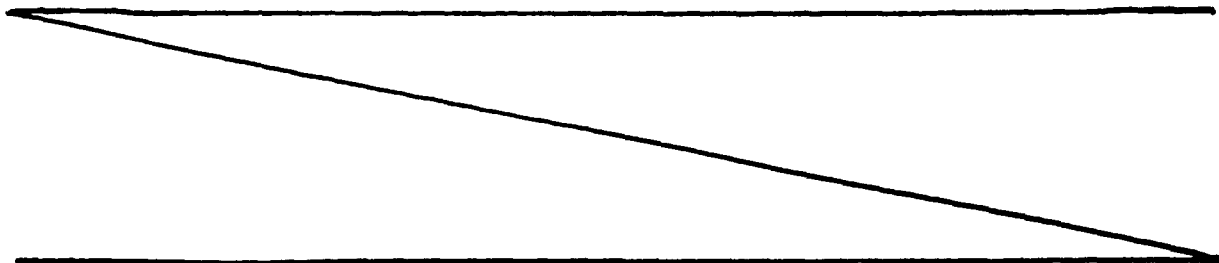
RESOLUTION AMENDING COUNCIL POLICY NO. 000-50 REGARDING EMERGENCY RESPONSE PLAN FOR THE HOMELESS.

WHEREAS, Council Policy 000-50 established a plan of action, entitled "Emergency Response Plan for the Homeless;" and

WHEREAS, current implementation in respect to weather conditions is inconsistent with other agencies in that the City defines extreme cold as 35° Fahrenheit or 40° Fahrenheit when precipitation is expected and other agencies define it as 40° Fahrenheit and 50° Fahrenheit, respectively; and

WHEREAS, it is necessary and desirable to secure consistency among agencies in respect to implementing the plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy No. 000-50 entitled, "EMERGENCY RESPONSE PLAN FOR THE HOMELESS," be and it is hereby amended by amending the first paragraph of the Policy section to include a definition of "extreme cold," said section to read as follows:



**POLICY:**

It shall be the policy of the Council to make City-owned facilities available to the homeless as temporary overnight shelters during periods of extreme cold, when no other facilities are available for this purpose. For purposes of this policy, "extreme cold" shall mean outside temperatures of 40° Fahrenheit or 50° Fahrenheit when precipitation is expected. The facilities and support staff, as appropriate, shall be made available, as feasible, in those areas that have the highest concentrations of homeless, particularly in and around the downtown area. The shelters will be opened to the homeless from 7:00 p.m. to 7:00 a.m. on nights when weather conditions are projected to be of a life-threatening nature in the metropolitan area. The determination to make the facilities available under this Emergency Response Plan shall be the responsibility of the City Manager's Office of Emergency Management.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to make the necessary changes to the Council

Policy Manual, and publish and distribute the new policy as may be necessary and required.
