RESOLUTION NUMBER R-278874

ADOPTED ON OCTOBER 21, 1991

WHEREAS, on July 25, 1991 the Planning Commission of The City of San Diego held a public hearing to consider siting of the Fiesta Island Facilities Replacement Project and the Northern Sludge Processing Facility; and

WHEREAS, the Council of The City of San Diego held a public hearing and approved the sitings at NAS Miramar West, which would require revision to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, San Diego Council Policy No. 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN may be scheduled concurrently with public hearings on proposed community plan amendments; and

WHEREAS, California Government Code Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four (4) times per year; and

WHEREAS, it is the intention of the City Council to consider amendments of the PROGRESS GUIDE AND GENERAL PLAN at hearings conducted on a semiannual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on these sitings that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN, but such changes shall not become effective until enacted at the semiannual hearings conducted to amend the PROGRESS GUIDE AND GENERAL PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall become effective at the next scheduled omnibus hearing.

2. That it is hereby certified that the information contained in ENVIRONMENTAL IMPACT REPORT DEP No. 91-0155, as amended by the Progress Guide and General Plan and on file in the office of the City Clerk in connection with this activity, has been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and has been reviewed and considered by this Council.
