BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and directed to begin immediate negotiations with the United States Navy in connection with the siting of the Fiesta Island Facilities Placement Project and the Northern Sludge Processing Facility at NAS Miramar West, while simultaneously processing the City's Environmental Impact Statement, and is further authorized and directed to find ways to comply with the Navy's conditions regarding noninterference with NAS flights, the geotechnical investigation and addressing the biological issues in connection with these sitings.
