WHEREAS, City Council of the City of San Diego adopted the recommendations of the North City Future Urbanizing Area Advisory Committee on July 8, 1991; and

WHEREAS, that Advisory Committee recommended the hiring of a consultant to prepare a Framework Plan to be adopted by the City Council; and

WHEREAS, the Alliance of Property Owners has offered a generous gift of \$100,000 to cover the costs of one-half of the consultant agreement and the City will provide a matching amount; and

WHEREAS, staff has followed the appropriate steps to advertise the project, screen the applicants, conduct interviews, and enter into negotiations with a preferred consultant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City Manager be and he is hereby authorized to execute an agreement with Blayney, Dyett and Greenberg, in an amount not to exceed \$199,000, for the purpose of preparing the North City

Future Urbanizing Framework Plan, in a period of approximately
nine months, for adoption by the City Council.
