RESOLUTION NUMBER R- 278890

ADOPTED ON OCT 22 1991

WHEREAS, on July 8, 1991, the Council of the City of San Diego adopted the recommendations of the North City Future Urbanizing Area Advisory Committee on July 8, 1991, to prepare a Framework Plan; and

WHEREAS, the Framework Plan will be prepared by a consultant pursuant to an agreement in an amount not to exceed \$199,000; and

WHEREAS, the City of San Diego and the Alliance of Property Owners are both contributing to fund the consultant's work; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it authorizes the Auditor and Comptroller to return \$34,000 of working capital advances from the General Garage and Machine Shop Equipment Fund (50031) to the General Fund 100 and further directs said \$34,000 be placed in the Allocated Reserve (901) for the sole and exclusive purpose of funding a Framework Plan for the Future Urbanizing Area.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend funds from the following accounts, in payment of the consultant agreement, to prepare a Framework Plan for North City Future Urbanizing area, a copy of which is on file in the office of the City Clerk as Document No. RR- 278090 : \$33,000 from the Engineering and Development Department Fund 100, Account 601651; \$18,883 from Water Utilities

Fund 41500, Account 032335; \$13,652 from Water Utilities Fund
41506, Account 039031; \$465 from Water Utilities Fund 41509,
Account 039041; and \$134,000 from the General Fund 100 Allocated
Reserve (901).
