BE IT FURTHER RESOLVED, that the City Manager is hereby directed to consider the following categories to be representative of the broadest public interest in the Future Urbanizing Area, although the City Manager, at his discretion, may consolidate, add, or substitute a different category if he deems it appropriate and necessary: Environmental, Housing, Large Property Owner, Small Property Owner, Park Planning, Non-motorized Transportation, Academician, Urban Designer,

Economist, Civic, Community.
