BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Planning Department report regarding City vernal pool acquisition, a copy of which is on file in the office of the City Clerk as Document No. RR-278892, is hereby approved.

2. That the City Manager is authorized to expend not to exceed \$528,000 from Vernal Pool Preservation Program Fund No. 10570, Account 9544, for the acquisition of property when identified, in the order set forth in said report, for the purposes of acquisition and management of vernal pools.

3. That the City Manager is hereby authorized to negotiate for the acquisition of said property and to accept a grant deed to any or all of said parcels, provided such purchase can be made within the limitations herein authorized for expenditure.

4. That the Auditor and Comptroller is authorized to return unexpended funds to the appropriate reserves upon the advice of the administering department.
